**Section One: Self-Employment Adjustment**

A. Does your Monthly Gross Income (Line 1 on the Child Support Worksheet) include any income from Self-Employment Yes

D. Multiply the amount in Line C by the Regular FICA Rate from the Reference Sheet (the last green colored page) and enter the result here ----- \$ \_\_\_\_\_

E. Enter the Maximum Self-Employment Adjustment from the Reference Sheet (the last green colored page) here ----- \$ \_\_\_\_\_

If you completed Line G, leave the rest of the Self-Employment Adjustment Section (Section One, H-S) blank and go to Section Two, Spousal Support Adjustment.

H. Enter the part of Monthly Gross Income which represents wages here ----- \$ \_\_\_\_\_

\* Wages, when used in this worksheet, refers to all earned income from which the payer must deduct FICA taxes from the paycheck and pay these taxes directly to the federal government and for which the payer must also pay a FICA tax which is equal to the amount deducted. Wages includes, but are not limited to, salaries, commissions, bonuses, severance pay and any other special payments received because of an individual's employment.

I. Enter the Maximum FICA-Covered Wages or Self-Employment Income from the Reference Sheet (the last green colored page) here ----- \$ \_\_\_\_\_

If Line H is equal to or greater than Line I, STOP here. You have no Self-Employment Adjustment because you pay the maximum FICA amount on your wages. Go to Section Two, Spousal Support Adjustment.

If Line H is less than Line I, go to Line J.

If Line J is greater than Line I, go to Line O.

## Section Three: Amount to be Entered on Line 1a of the Child Support Worksheet

- A. Go to Section One, Lines F, M and R. (Either one of these lines contains an amount or none does). Enter the amount found or zero here----- \$ \_\_\_\_\_
- B. Go to Section Two, Line B. Enter the amount found or zero here----- \$+ \_\_\_\_\_
